### **Position Summary:**

The Director, Air Navigation and Safety Policy reports the Permanent Representatives of ICCAIA at the Montreal Head Office.

Principal duties include:



- Providing secretariat support for ICCAIA's Airworthiness and CNS/ATM (Communications, Navigation, Surveillance / Air Traffic Management) Committees and their working groups, and other ICCAIA advisory groups on related topics
- Coordinating positions and activities between ICCAIA Committees, working groups and advisory groups;
- Coordinating positions developed by ICCAIA's panel member representatives to ensure agreement across ICCAIA's membership consistent with ICCAIA's internal 5-Year Strategy;
- Attending ANC Working Group meetings to analyse impacts on the manufacturing industry and coordinate inputs with ICCAIA's expert community;
- Attending industry group meetings on Safety, airworthiness and CNS/ATM related subjects;
- Serving as ICCAIA Alternate Observer on the Air Navigation Commission;
- Facilitating engagement between ICCAIA representatives and ICAO officials;
- Communicating positions on behalf of ICCAIA;
- Defining and coordinating ICCAIA attendance at relevant High Level Meetings;
- Coordinating membership of ICCAIA Committees and ICAO panels in relevant fields;
- Developing, reviewing and refining ICCAIA papers as input to high level meetings;
- Facilitating the review and tracking of other participants' positions at high level meetings to ensure manufacturer's interests are identified and represented;
- Attending other meetings as necessary and serving as the ICCAIA member on expert groups if needed;
- Coordinating with ICCAIA Committee Chairs, Vice-Chairs and nominated experts on relevant issues, including ICAO State Letters and subsequent responses;
- Liaising with ICAO officials and staff, Contracting States' representatives to ICAO, and officials and staff of other Observer Organizations located in Montreal;
- Coordinating attendance and representation at ICAO regional meetings.

## The ideal candidate will have the following technical skills and knowledge

- At least 5 years of experience with an aerospace manufacturer, maintenance and repair organisation (MRO), certification authority or international organization;
- In-depth understanding of airworthiness of aviation communications/navigation systems;
- Technical and geopolitical acumen, awareness of the current and future direction of aviation manufacturing and related aviation/aerospace industries;
- A degree in a relevant field;
- Understanding of development of ICAO Standards, Recommended Practices, Procedures for air navigation and/or national regulation;
- Able to interpret regulation and anticipate potential impacts on industry
- Awareness and understanding of the role of International Organizations;
